**SCHOLARSHIPS FOR STUDENTS ENROLLED IN THE MASTER'S DEGREE
PROGRAMME IN "ADVANCED MOLECULAR SCIENCES FOR HEALTH PRODUCTS"
AT THE DEPARTMENT OF FOOD AND PHARMACEUTICAL SCIENCES OF THE
UNIVERSITY OF PARMA**

The Department of Food and Drug Sciences of the University of Parma establishes, by Decree of the Director 272/2025 of 3 September 2025, two scholarships worth a total of €36,000.00 each (including IRAP), i.e. €18,000.00 per academic year, to be awarded for the academic years 2025/2026 and 2026/2027 to students enrolled in the Master's Degree programme in Advanced Molecular Sciences for Health Products, in order to subsidise their studies.

ELIGIBLE CANDIDATES

Applications may be submitted by enrolled students or prospective students who have passed the pre-enrolment procedure and intend to enrol in the Master's Degree programme in Advanced Molecular Sciences for Health Products (LM-54 R) at the University of Parma.

ADMISSION REQUIREMENTS

- Be a citizen of a non-EU country (with the exception of the UK, USA, Canada, Japan)
- Have passed the pre-enrolment procedure for enrolment in the Master's Degree course in Advanced Molecular Sciences for Health Products (LM-54 R) at the University of Parma.

HOW TO SUBMIT YOUR APPLICATION

The application form, completed in accordance with Annex 1, must be received no later than

18/09/2025 using one of the following methods:

- photocopy of a valid identity document
- letter of motivation and any letters of recommendation
- self-certification of the qualification obtained with a list of exams taken.

Incomplete applications will not be considered; once the deadline has passed, it will not be possible to replace qualifications and/or documents that have already been submitted.

RANKING LIST

The Selection Committee is appointed by the Director of the Department of Food and Drug Sciences of the University of Parma at the end of the call for applications. The ranking list will be drawn up based on the Committee's unquestionable judgement of the following criteria:

- University career
- Curriculum vitae et studiorum
- Candidate's motivation

The ranking list will be published in the University's official register and on the Department's website.

ACCEPTANCE AND PAYMENT OF THE AWARD

The winner will be notified of the award of the scholarship exclusively by email to the address indicated in the application form.

The winner must reply to the above email with a declaration of acceptance of the award within 7 days of receiving the notification.

The award will be revoked in the following cases:

- failure to send the acceptance
- withdrawal from studies
- transfer to another university or another course of study
